- I hereby release and shall indemnify and hold harmless RIC and its agents, officers and employees from and against any and all liabilities, obligations, losses, injuries, claims, damages, costs and expenses including attorney's fees and costs of defense, arising out of or connected with injury, sickness, disease or death to persons or damage to property or consequential damages arising out of or in any way connected with my receiving an assessment by RIC physicians in connection with my participation in the Event.
